I understand that as a coach within Mauldin Parks and Recreation (MBSA), I am responsible for the conduct of my fellow coaches, my players and the parents of those players. I will insure that the harassment of any umpire, player, opposing player, manager, coach or league official is not tolerated. I will not openly question an officials or umpires decision. I will control my emotions and avoid arguments and confrontations at all costs.

I will insure that a drug, alcohol and tobacco free sports is environment is present at all times (including practices as well as games). I will not use cursing or abusive language around any player, toward any player, around any parent of a player, toward any parent of any parent or at any time while on City of Mauldin property or engaged before, during or after a Mauldin Parks and Recreation (MBSA) function. I will not touch, grab or engage any child in any physical manner inappropriate to their parents or legal guardian or Mauldin Parks and Recreation (MBSA). Establish such physical guidelines with every parent prior to the beginning of such season.
